

Special FPOA Meeting...

A special meeting of the FPOA membership has been called for Saturday, October 24th, at 3:00PM, to be held in the Observatory Lecture Room. The purpose of the meeting is to approve amendments to our Bylaws necessitated by organizational changes in the Department of Parks and Recreation. Prior to these organizational changes, the FPOA was required to have a representative of the DPR on our Board. This requirement has now changed, and it is necessary to modify our Bylaws to reflect that change.

The essence of the Bylaws changes are as follows: remove references to both "Executive Secretary" and "Recording Secretary", and replace them with the generic term "Secretary". Remove the paragraph

that states that the Executive Secretary is a designate of the Superintendent of the Gabilan Mountains district.

Additionally, a paragraph has been added to the Bylaws to clarify eligibility requirements for members wishing to run for a position on the Board.

Copies of the amended Bylaws will be available at the Observatory on the 24th prior to the meeting for any member to review.

If you can make it to the meeting you are encouraged to do so, as your vote on this matter is important.
